- **DEFAULT IN LIFTING**: In case of any default in lifting of materials by the Buyer • within the prescribed free time limit, the outstanding material may be lifted subject to payment of Ground Rent by the Buyer directly to the SELLER for the period of delay up to 2 weeks maximum, provided written request is received before the expiry of the free lifting period. All matters relating to charging of Ground Rate will be decided by the In case of Goods sold on Lot Basis, the Ground Rent will be calculated on the value of the entire Lot even if lifted in part, where as in case of Goods sold on Unit Weight or Unit Number Basis, the Ground Rent will be calculated on the value of unlifted quantity. - **DISPUTES:** In case of any dispute, the same shall be referred to a single arbitrator, to be appointed by the SELLER and the Arbitration proceedings would be governed by "Arbitration and Conciliation Act" 1996. The fees and expenses towards arbitration proceedings shall be shared, equally, by the parties to the dispute. The jurisdiction for appealing against the award in a court, or any other proceedings under the Arbitration Act, shall be that of courts in Delhi only.

- The SELLER will not be in any way responsible for failure to deliver the goods as per delivery schedule due to causes beyond their control such as strikes, lockouts, shortened hours, act of God or other causes or contingency whatsoever.
